

Franchise Agreement
Between
The Town of Croydon, New Hampshire
And
**Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North
Carolina/Virginia/Vermont, LLC**

WHEREAS, Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/Virginia/Vermont, LLC, (hereinafter "Comcast" or "Franchisee") is the duly authorized holder of a franchise to operate a cable communications system in the Town of Sunapee, New Hampshire, said Franchise having been granted April 22, 2008, which is contiguous to an area in the Town of Croydon, New Hampshire ("Croydon"); and

WHEREAS, cable television services are not presently available to the first three residences on Old Springfield Road, beginning at 447 Old Springfield Rd., by any other franchise cable system operator; and

WHEREAS, three homes 447, 455, 460 Old Springfield Road near the Sunapee town line are desirous of cable television services; and

WHEREAS, Comcast has developed a construction estimate based on serving these three homes from Comcast's Sunapee plant for the foreseeable future and any changes thereto will be solely at the discretion of Comcast or Comcast's successor in interest; and

WHEREAS, the Town of Croydon has held a duly notice public hearing pursuant to RSA53-C:3-a and has considered the financial ability of Comcast to perform; the ability of Comcast to provide adequate and technically sound facilities, equipment and signal quality; adequate channel capacity and appropriate facilities for public, educational, or governmental use, taking into account available technology, subscriber interest, and cost; the prohibition of discrimination among customers of basic service; reasonable service quality in terms of available technology, subscriber interest, and cost; construction and installation which conforms to all applicable state and federal laws and regulations and the National Electric Safety Code; a competent staff able to provide prompt, adequate service and to respond comprehensively to

customer complaints or problems; and reasonable rules and policies for line extensions and disconnects, customer deposits, and billing practices.

NOW THEREFORE, it is agreed that a non-exclusive Franchise is granted by the Town of Croydon to Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/Virginia/Vermont, LLC in accordance with Federal and State law to permit Comcast to provide cable television service from the current end of line in Sunapee to Pole # 24/24 at or near 460 Old Springfield Rd. (currently the third house from the town line) in the Town of Croydon, and are within one hundred twenty-five (125) feet of the cable feeder line. The term of the Franchise shall commence on the date of execution hereof by the parties and ends in ten years, at midnight on July 28, 2019.

IN WITNESS WHEREOF, the Town of Croydon has caused this document to be duly executed in its name by its Selectman and Comcast has similarly executed this document on July 28, 2009.


