





- 1) a. REINFORCING BARS SHALL BE ASTM A615 GRADE 60, GALVANIZED.
- b. WELDED WIRE FABRIC SHALL COMPLY TO ASTM A497, GRADE 60 GALVANIZED. REFER TO WELDED WIRE MESH ALTERNATE DETAIL FOR SPACING AND
- 2) CONCRETE FOR PRECAST PANELS SHALL HAVE A MINIMUM COMPRESSIVE STRENGTH AFTER 28 DAYS OF 4000 p.s.i., OR AS REQUIRED BY THE
- 3) TIE STRIPS SHALL BE STEEL ASTM A1011 SS, GRADE 50 (FORMERLY ASTM A570) (GALVANIZED PER ASTM A-123).
- 4) ALL FRONT EDGES OF PANELS SHALL HAVE A 1/2" CHAMFER.
- 5) TIE STRIPS SHALL BE PLACED WITHIN 1" OF THE DIMENSION SHOWN ON THE FABRICATION DRAWINGS.
- 6) PANEL DESIGN THICKNESS IS 5 1/2". THE QUANTITY OF CONCRETE WILL INCREASE TO ACCOMODATE ANY ARCHITECTURAL SURFACE FINISH THAT
- 7) VERTICAL REINFORCING BARS SHALL BE PLACED 1 1/2" (MIN.) CLEAR FROM THE BACK FACE OF THE PANEL.








ELEVATION - BACK FACE




HORIZONTAL SECTION W/4 TIE STRIPS








HORIZONTAL SECTION W/7 TIE STRIPS




CORNER ELEMENT TYPICAL SECTIONS
